Section 1: Description

Description

The following information provides a functional description of the LHS RHS Sliding Door, Long Line Floor Protection, Kit as defined in Alpine Aerotech LP authority dataset AAL-312-020-006.

- The Floor Protection, Kits are rigid pieces of material that are installed atop the existing floor to protect it from dents and punctures associated with typical aircraft usage. This occurs most frequently during loading and unloading operations, but can also occur during small inflight shifts of said cargo.
- The LHS RHS Sliding Door, Long Line Floor Protection, Kit when installed, adds additional protection to the floor panels, as it is manufactured from a material specifically designed to spread and attenuate energy.

- I. Perform a Detailed Inspection on all items to ensure proper security.
- II. Perform a Detailed Inspection on all items/materials to ensure proper integrity.
- III. Perform a Detailed Inspection on the LHS RHS Sliding Door, Long Line Floor Protection, Kit to ensure that it is not delaminating.
- IV. Perform a Detailed Inspection on all surfaces & locations with Velcro applied to ensure no damage has occurred to the aircraft.

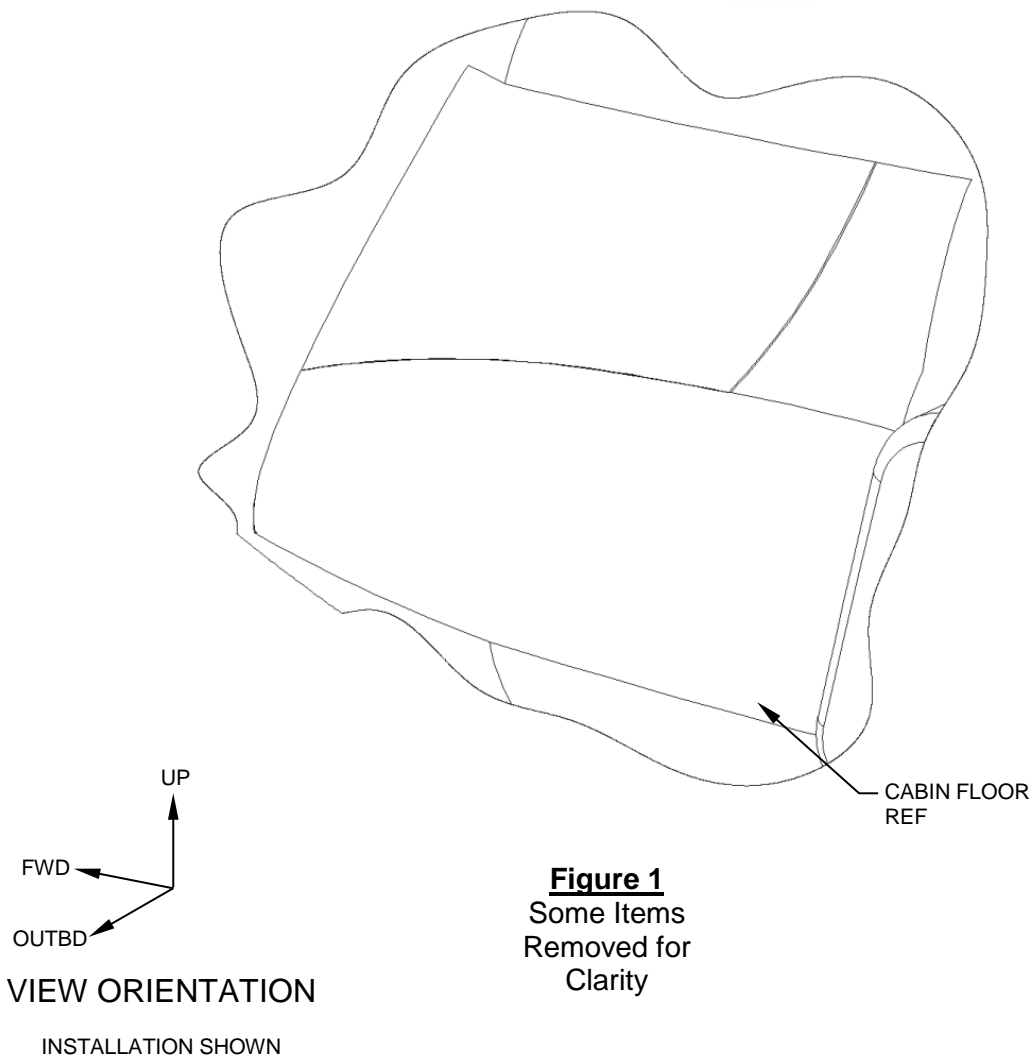

Installation Instructions

1. Gain access to the cabin floor, temporarily remove all seats, LHS collective, & foot pedals. Remove any existing floor board protection kits, door sills, sliding door transition sill and all related fasteners. Reference Figure 1.



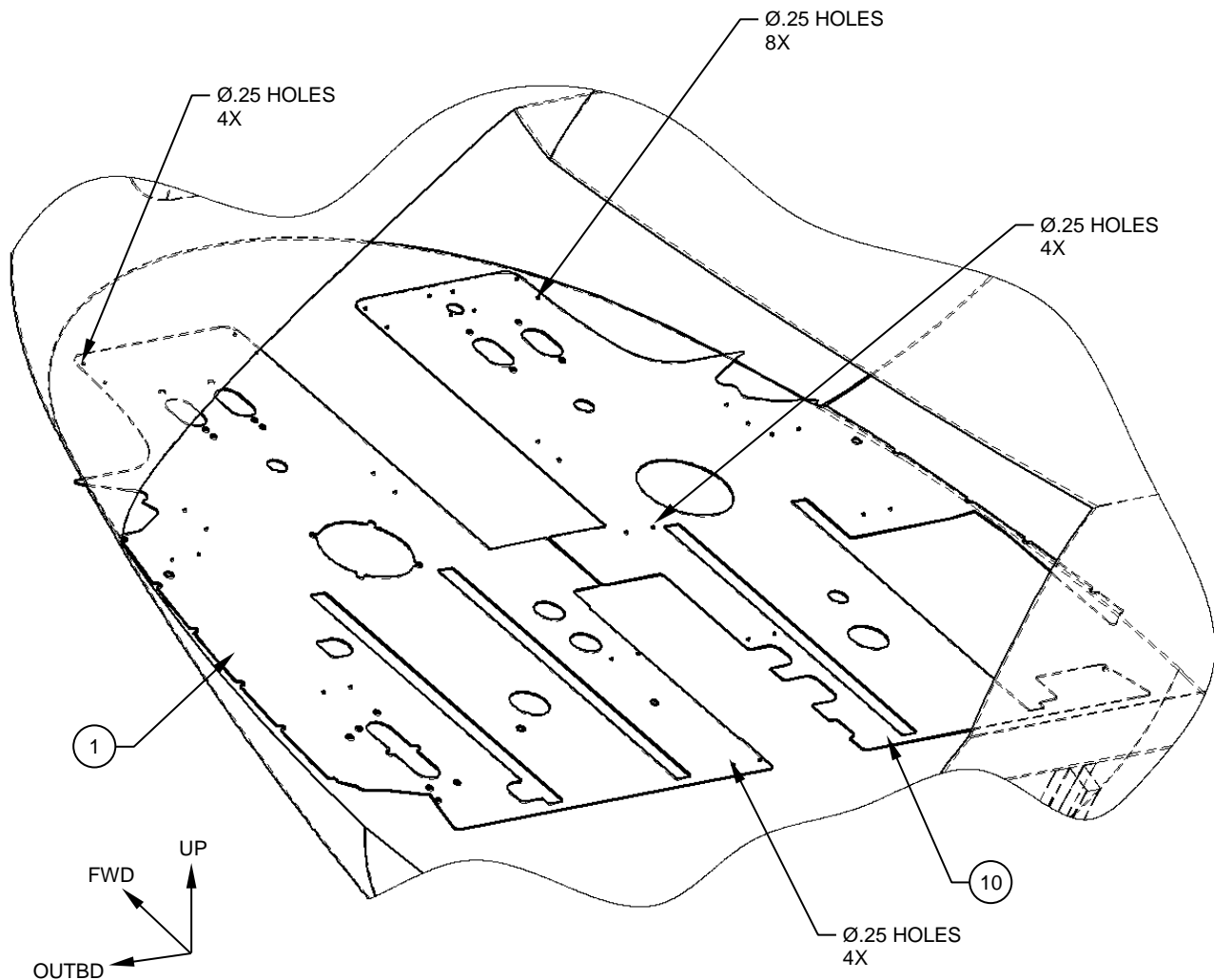

2. Pre-fit the FWD LHS Sliding Door Floor Protection, Assy (Item 1) & FWD RHS Sliding Door Floor Protection, Assy (Item 10) by lining up the outboard edge of the panel, assy with the existing floor panel edge. Reference Figure 2.

Note: Ensure clearance around cutout features, cyclic, collective, & pedals etc.

3. With the panel lined up use the pre-cut $\text{\O} .25$ holes and a felt pen to mark out the locations for the Velcro, Details (Items 6, 17 & 18) and remove the panels (Items 1 & 10). Reference Figure 2.

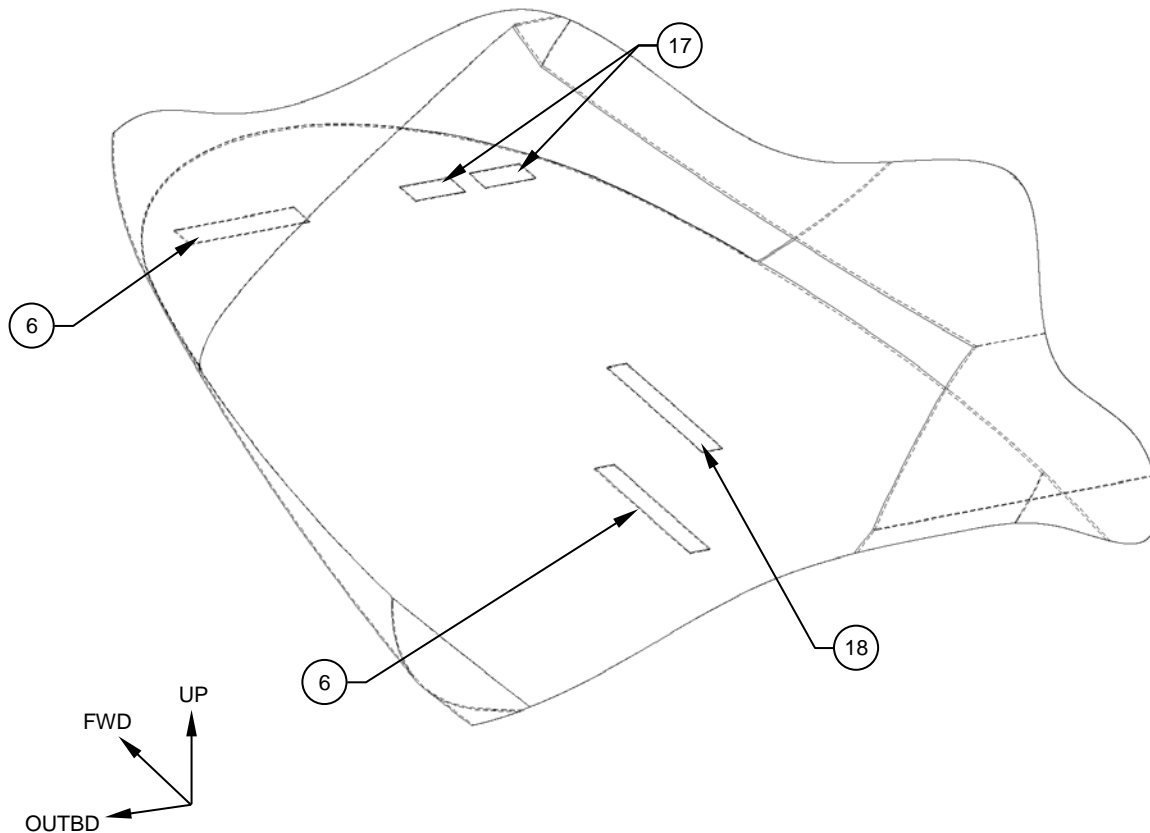

Installation Instructions

4. Clean the areas between the felt pen marks with alcohol taking care not to wipe away the felt pen marks.
5. Individually separate each Velcro, Detail (Item 6) off of the FWD LHS Sliding Door Floor Protection, Assy (Item 1) and Velcro, Detail (Items 17 & 18) off of the FWD RHS Sliding Door Floor Protection, Assy (Item 10) peel adhesive backing from the Velcro, Details (Items 6, 17 & 18).
6. Using the felt pen marks as reference points, apply the Velcro, Details (Items 6, 17 & 18) to the floor board panel in their respective locations. Reference Figure 3. Apply adequate pressure to ensure a secure bond.

7. Re-install the FWD LHS Sliding Door Floor Protection, Assy (Item 1) & FWD RHS Sliding Door Floor Protection, Assy (Item 10) onto Velcro strips. Reference Figures 2 & 3.

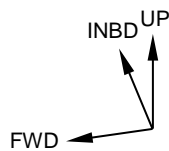
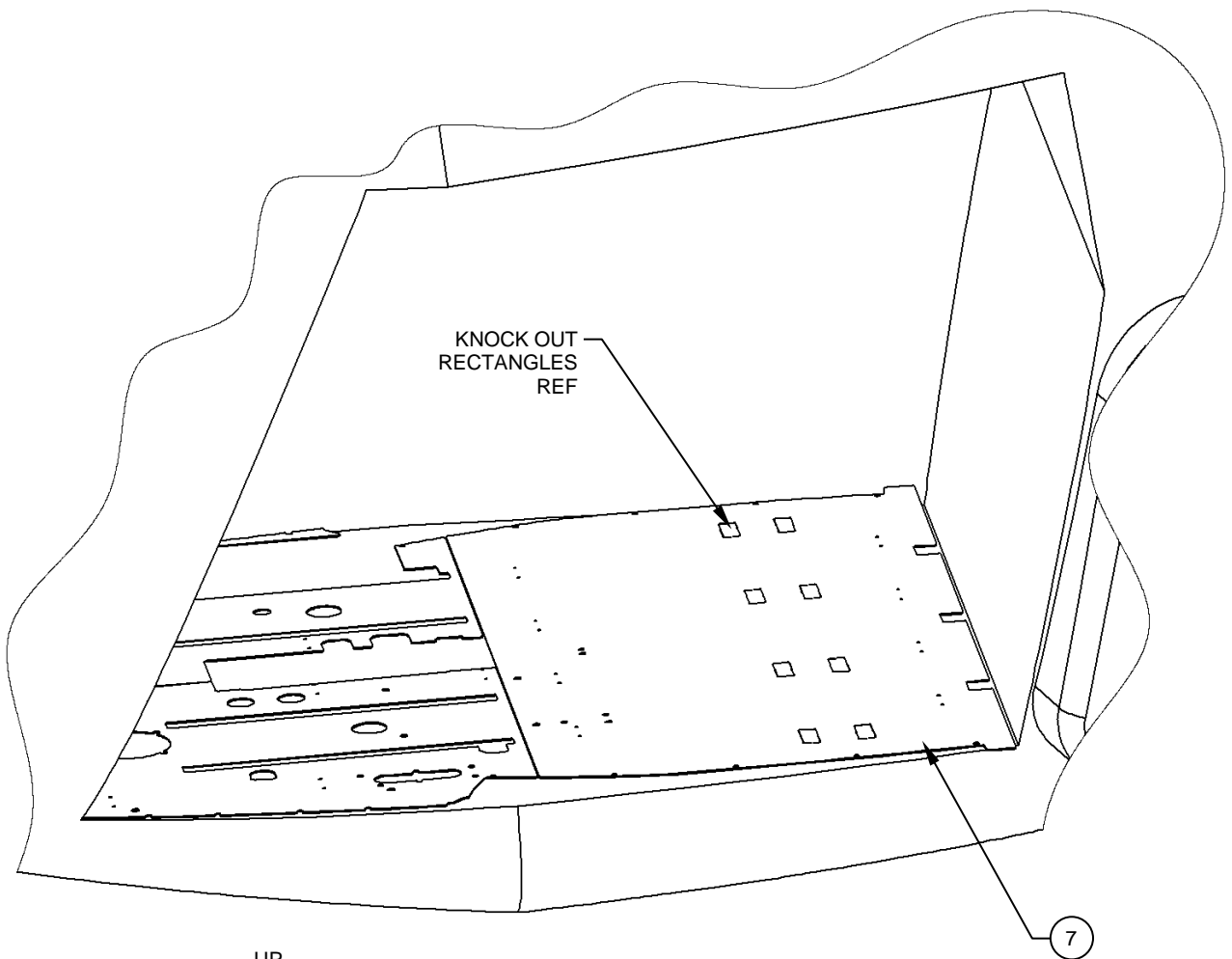


Installation Instructions

- Fit the AFT Sliding Door Floor Protection, Assy (Item 7) by picking up on the pre-existing holes where the sliding door transition sill mounts. Reference Figure 4.

Note: Ensure clearance around cutout features, cyclic, collective, & pedals etc.

- If required use a sharp utility knife to remove **EITHER** the FWD or AFT set of knock out rectangles to allow the Aft seats to be properly fastened. Reference Figure 4



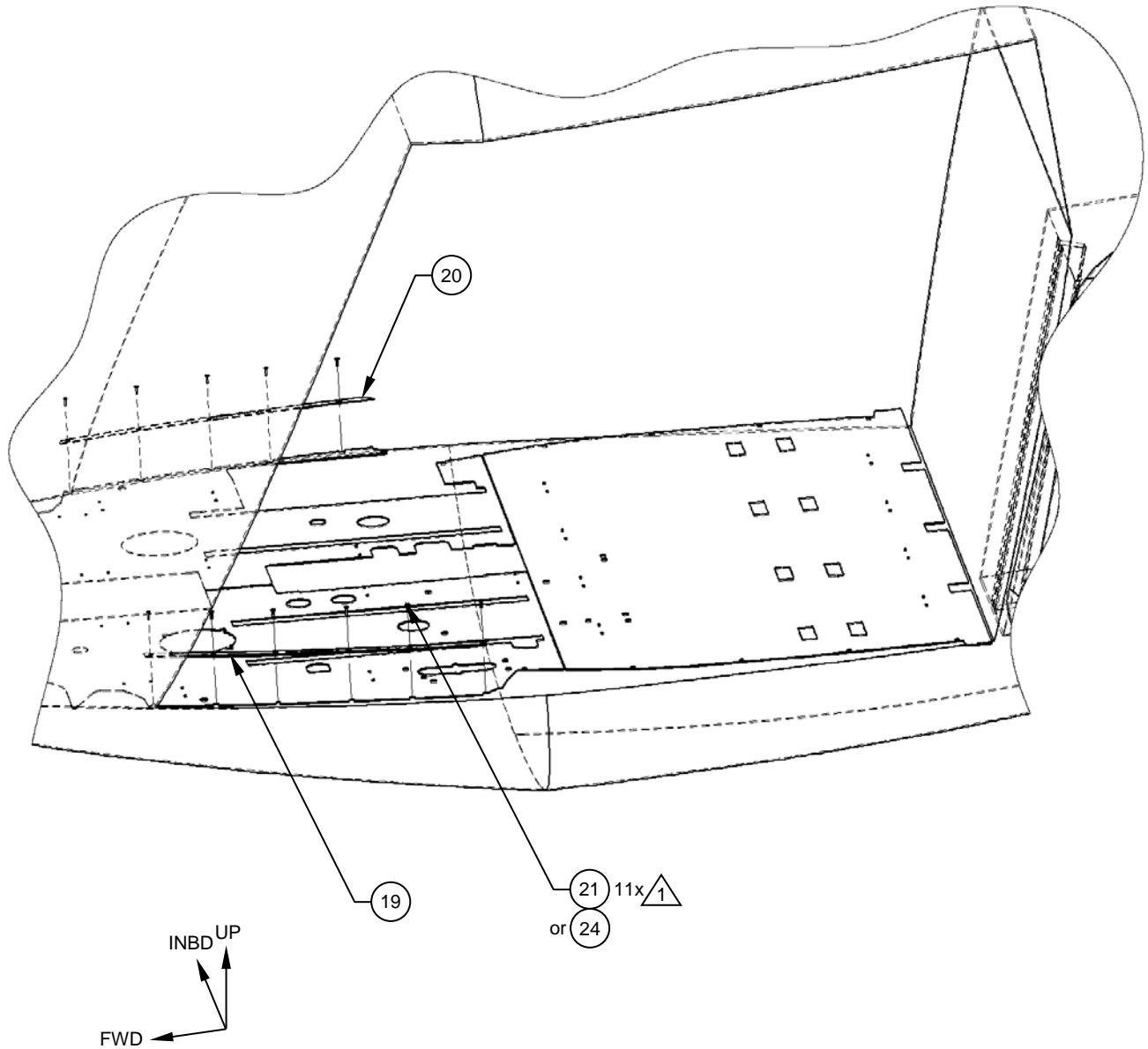

10. Install Door Sill, Details (Items 19 & 20) as shown, using supplied hardware Screw, Machine (Item 21). Reference Figure 5.



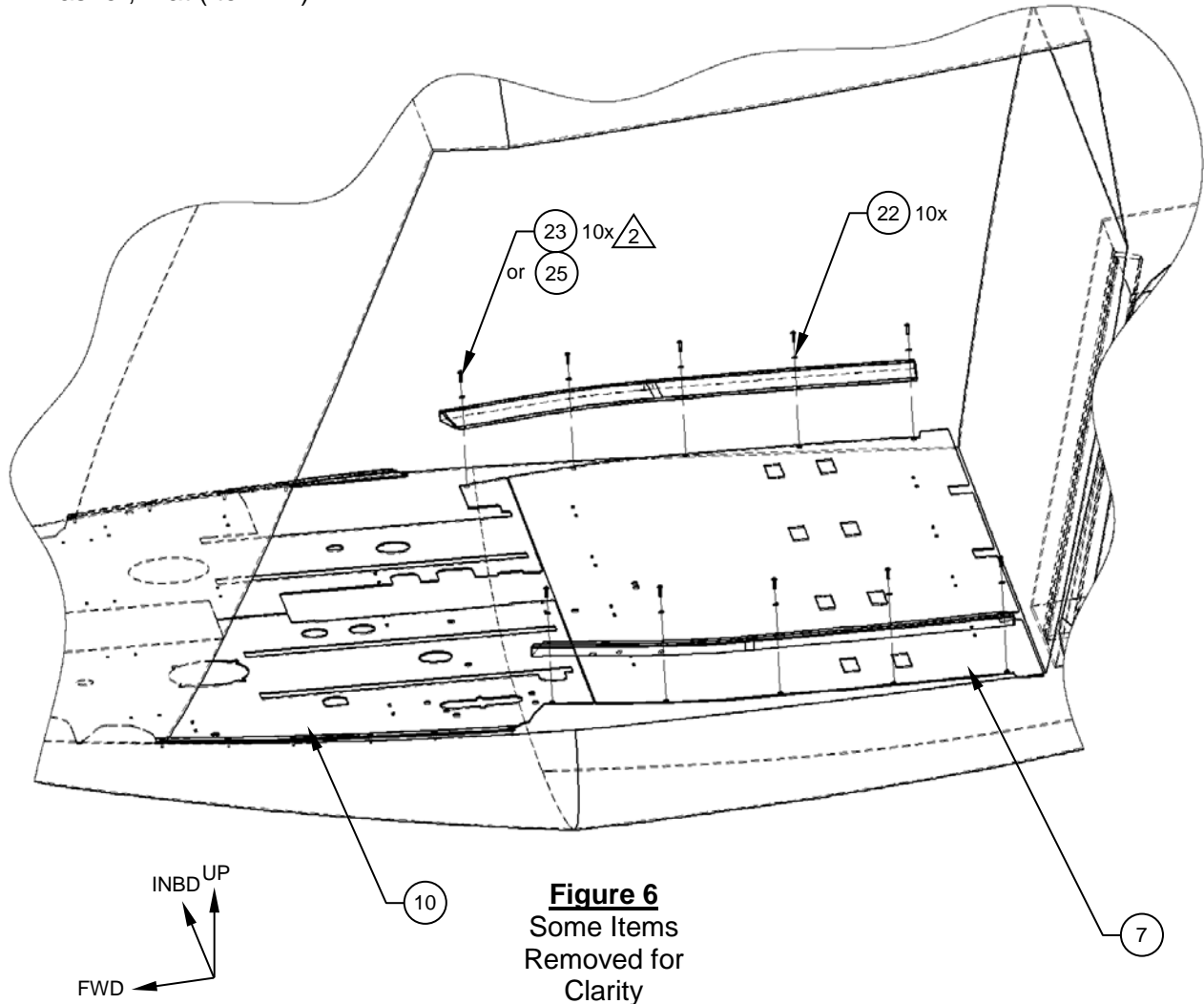

11. Re-install the sliding door transition sill over top of the AFT Sliding Door Floor Protection, Assy (Item 7), FWD LHS Hinged Door Floor Protection, Assy (Item 1), FWD RHS Hinged Door Floor Protection, Assy (Item 10) and fasten with provided hardware, Screw, Machine (Item 23) & Washer, Flat (Item 22).

13. Perform a General Inspection of all items to ensure proper installation.
14. Update the aircraft logbook for the installation of LHS RHS Sliding Door, Long Line Floor Protection, Kit.



Removal Instructions

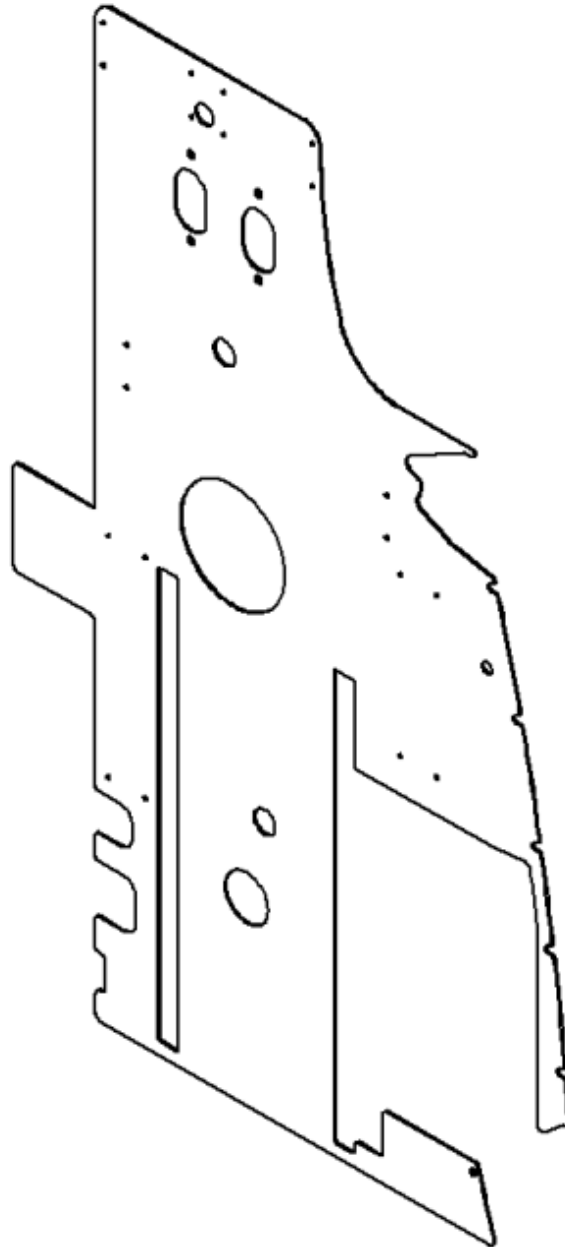
1. For the removal the LHS RHS Sliding Door, Long Line Floor Protection, Kit for either inspections, or mission configuration, the removal of the LHS RHS Sliding Door, Long Line Floor Protection, Kit can be considered the opposite of installation for step 7 & 8. For permanent removal, of LHS RHS Sliding Door, Long Line Floor Protection, Kit remove all bonded Velcro, Details.
2. Perform a General Inspection of all items to ensure proper removal.
3. Update the aircraft logbook for the removal of the LHS RHS Sliding Door, Long Line Floor Protection, Kit.



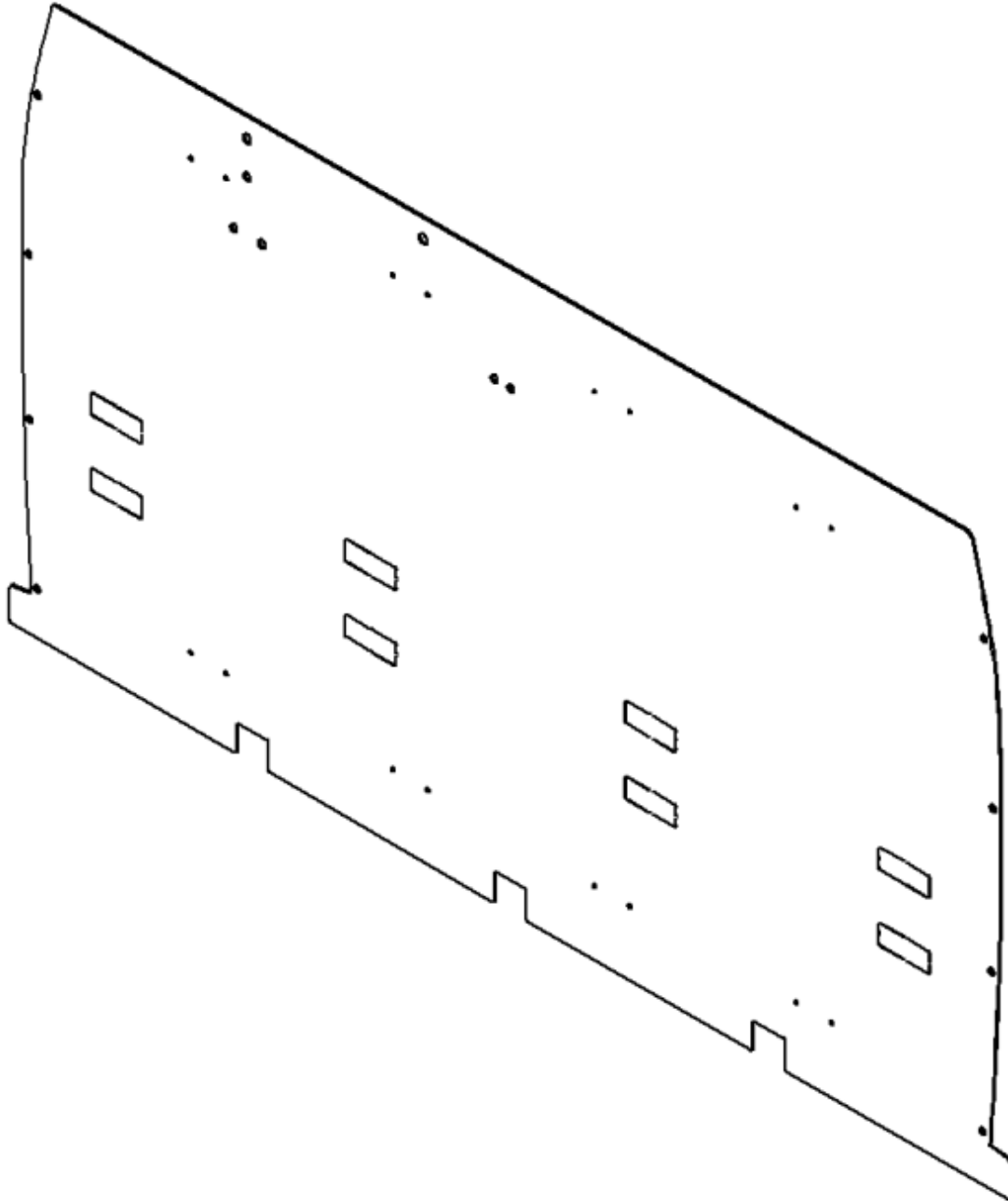

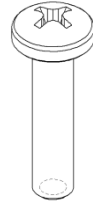

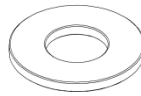
